Research experience:

My research activities are - as is seen from the list of publications below - mainly related to macroeconomic modelling and applied econometrics. The latter comprises panel data econometrics with micro data as well as dynamic modelling with macroeconomic time series data.

At Norges Bank I was responsible for the Research department through a period when the research activities grew from near zero to 15 man-years. The department achieved good academic standards in fields relevant to a central bank - econometric modelling of the evolving macro economy, studies of financial markets and monetary economics.

The Econometrics of Macroeconomic Modelling (Oxford University Press, 2005) – joint work with Gunnar Bårdsen, Øyvind Eitrheim and Ragnar Nymoen – describes the empirical research program and some of the main lessons we have learned from 20 years of macroeconometric modelling at Norges Bank. The book was my idea, responding to a request from professor Clive Granger in 1999.

Since the fall 2005 I have pursued this program at Statistics Norway by doing applied empirical macroeconometric research linked up to the macroeconomic models KVARTS and MODAG. I have also been the project manager for the project "The role of local government in the macro economy", funded by The Norwegian Association of Local and Regional Authorities (Kommunenes Sentralforbund), 2006 - 2008.
